In some areas a much higher density level may be appropriate and have been successfully achieved recently within the village. There is however other parts of the settlement which currently have very low density and new significantly higher density developments would sit very uncomfortably with these existing local settlement areas. We consider that Para A needs strengthening to allow new development perhaps at a significantly lower density than 30 houses per an hectare providing it provides the highest possible density while still appropriate to their surroundings.
